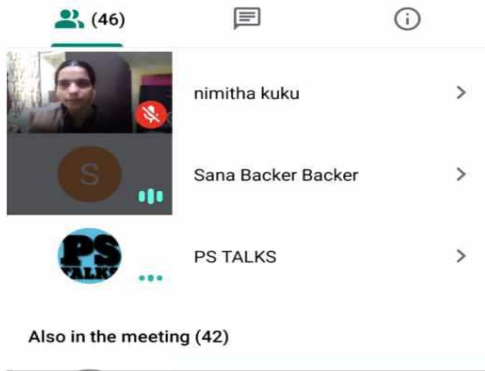
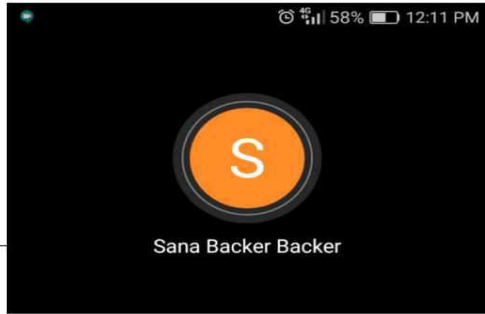
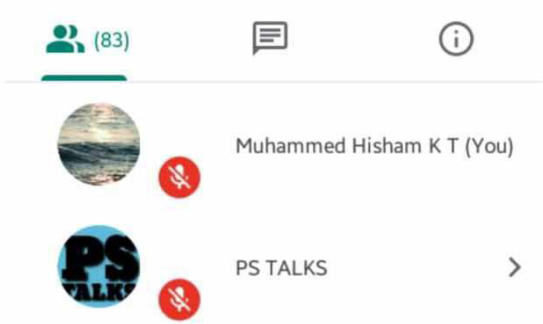
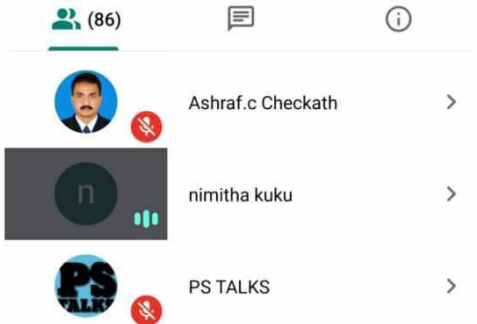
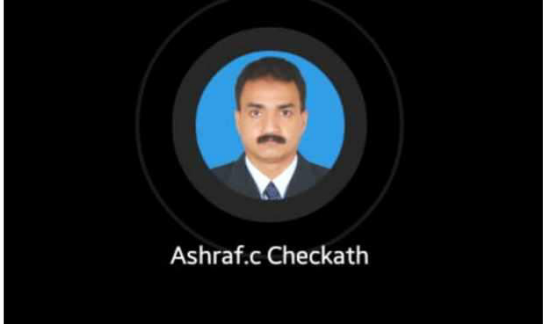
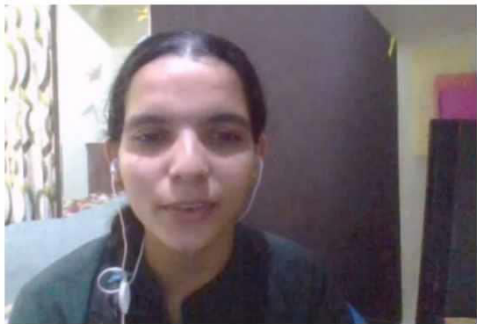
Later on, the guest pointed out few tips to be followed in order to achieve mental fitness. They were as follows:
